Fingerprint Clearance

All volunteers may be subject to fingerprint clearance which is mandated the State of California Public Resources Code 5164. Fingerprints must be cleared through the State of California Department of Justice and clearance received by GVRD before the first day work.

If your volunteer position will bring you into contact with minors (those under 18), you must be fingerprinted. If you have been accepted as a volunteer, the Recreation Coordinator will advise you if you

must be fingerprinted and the procedures to follow. The Greater Vallejo Recreation District will pay for all volunteer fingerprinting costs
